### IPE Clinical Experience Guides

OHNEP has developed four innovative interprofessional oral health clinical experiences for students across health professions. These model oral health simulation and live clinical experiences are designed to operationalize the IPEC Core Competencies while building oral-systemic competencies. Students from nursing, dental and other health professions can work together to develop collaborative management plans that meet the oral and overall health needs of patients across the lifespan through oral health screening, education and referral.

## Santa Fe Group Submits Nominations for Medically-Necessary Dental Coverage to the Centers for Medicare & Medicaid Services

In February 2023, the Santa Fe Group (SFG) submitted nominations of dental services for medical coverage to the Centers for Medicare and Medicaid Coverage (CMS). Research evidence supports that coverage of inextricably linked oral health care services will make possible unprecedented progress in the management of diabetes and blood and solid tumor cancers. Expanding dental care coverage has great potential to improve population health and health equity in the US, as these chronic conditions impact medically and dentally underserved individuals at disproportionate rates.

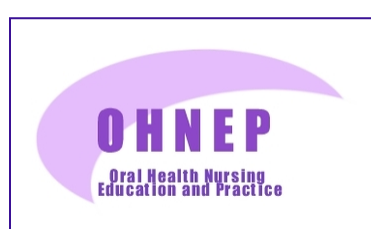
